1. The annual Enrollment Contract is valid September 1 through August 31. Annual Tuition is re-evaluated with each school year. Annual Tuition is divided into equal monthly installments for your convenience.
2. A non-refundable Application Fee of \$50 is due at the time of application for each child (unless applying for Tuition Aid or receiving County Child Care Assistance Program or State Early Learning Scholarships).
3. A one-time Registration Fee of \$400 is due with a signed Enrollment Contract for each child upon acceptance. An alternate rate of \$125 is offered for recipients of County CCAP (Child Care Assistance Program) or State Early Learning Scholarships.
4. A non-refundable Annual Re-Enrollment/Materials Fee of \$300 is collected at the time of re-enrollment each year. An alternate rate of \$125 is offered for recipients of County CCAP (Child Care Assistance Program) or State Early Learning Scholarships.
5. CRMS requires 60 days notice to cancel the annual Enrollment Contract. Families will be obligated to pay the prorated tuition for 60 days following notification of intent to withdraw.
6. Tuition adjustments for mid-year schedule changes will be subject to a 30-day notice following notification of the requested change.
7. Tuition Aid is available to qualifying families. Applications for Tuition Aid are processed by the school's Tuition Aid Committee and reviewed on a case-by-case basis. Tuition Aid awards are available on a limited basis, and re-evaluated during the re-enrollment period each year. Families must resubmit a new application each school year and notify CRMS of any changes to financial situation on an ongoing basis. All families are encouraged to apply. See Tuition Aid Info and Application 2026-2027 for more details.
8. A 5% tuition discount applies for the oldest enrolled sibling (cannot be combined with other discounts).
9. Extended Care Hours may be available on a per diem basis at \$10 per hour. Families are asked to seek approval from Administration at least 24 hours in advance. Extended Care Hours are not guaranteed, and approval is contingent on the number of children and staff already scheduled.
10. For a late pick up, Parent/Guardian agrees to pay a charge of \$5.00 after the first five minutes past the contracted program time and \$1.00 per additional minute late.
11. Tuition payments received after the 5th of the month will be assessed a \$25.00 late fee.
12. Nutritious snacks are included in tuition for all programs. Daily hot lunch is also included with all programs, with the exception of Toddler Community Half Days (8:30-11:30am).
